Every rider needs to be a full member of GTPA e.V.(at the latest to 31/03/2014) or a similar association other nations. Every rider may start 5 times. One rider cannot show Cattle Penning more than two times. Per horse maximum 7 announcements are possible. As an Open rider you cannot show in Cattle Penning "Limited Open". Open rider is, who is classified as one because of his/her performances in the association (look for example at the GTPA ranking) or if you earn your money with training horses or riders. For team Penning "Limited Open" one Open Rider in every Team is allowed (have a look at the Ranking GTPA for members).

**Rulebook:** The Show will be judged according to the official rulebook of GTPA which is

attached.

**Disqualification:** You will be disqualified by any break of rules. You will not reimburse the fees

or any other expansions.

**Qualification:** The 10 best riders will be qualified for the finals.

At a number of 25 riders in every discipline, the whole Fees are in the jackpot. In Limited Open classes 40% of the jackpot will be declared, in Open classes 60% of the jackpot will be declared. In Youth classes no money will be declared they will take other awards.

homepage. Other sashes, Trophies or Buckles will be given.

#### Do not forget your hors passport!

A loadable vaccination protection against tetanus and Influenza is to be proved. The Influenza-vaccination should date back no longer as 6 months. Horses, which do not have a passport or all vaccinations, cannot be shown. You will not get back your fees.

# A topical official certificate of the health of all horses, who do not come from Germany, must be presented with naming!

If a horse has a contagious disease the owner is liable for all resulting damage.

You have no claim for refund by a last- minute cancellation (3 weeks before the Show starts). The show manager can cancel the show if there are not enough riders. If this is happening, you get the already paid fees back.
